Professor Venkat Rao Pulla is an internationally recognized social work scholar and practitioner. His strengths-based approach is rooted in a strong ethical framework that prioritizes client

well-being and autonomy while advocating for societal change. Professor Pulla's research emphasizes the ethical benefits of strengths-based techniques, resulting in more effective, empowering interventions. He promotes global collaboration by publishing much of his work under a Creative Commons license. A passionate advocate for community service and academic exchange, Professor Pulla maintains strong ties with Bharat, mentoring countless academics and social work professionals.

An expert in Grounded Theory and qualitative methods, Professor Pulla has supervised doctoral research across diverse fields of social and allied health sciences. Professor Pulla held the position of Foundation Head at the School of Social Work, Northern Territory University, and has taught at several prestigious institutions, including Monash University, Australian Catholic University, and James Cook University.

A prolific researcher and writer, Professor Pulla serves on editorial boards of several journals and is the Editorin-Chief of Journal Space and Culture, India, published form the UK and is an Associate Editor of SN Social Sciences - Open Springer. His numerous publications include books on strengths-based practice, resilience, and community empowerment, with works published internationally by Allied Publishers, Palgrave Macmillan, and Springer.

In India, he received the Ashoka Fellowship (1987-1988), the Global Indian Karma Veer Puraskar (2008), and the Lifetime Achievement Award from NAPSWI for significant contributions to social work. Currently, he is a Distinguished Professor of Social Work and Strategic Advisor, at the Institute of Health Management IHM, Melbourne, a Foundation Professor of Strengths-Based-Social Work Practice, at Brisbane Institute of Strengths-Based Practice, Australia and an Adjunct Associate Professor at the College of Arts, Society & Education, James Cook University, Australia.

Overview

The strengths-based model offers immense potential for Indian social work practitioners to drive social change by leveraging local assets, cultural resources, and community networks. This approach effectively addresses complex societal challenges like marginalization and inequality while enhancing human service organizations and fostering applied research for sustainable, inclusive development.

A five-day curriculum focuses on transitioning from problem-focused methods to solution-oriented practices, emphasizing proactive approaches. Key components include strengthening human service organizations, aligning leadership with strengths-based principles, and equipping participants with practical skills to assess strengths, evaluate interventions, and engage in applied research.

The program targets advanced MSW students, doctoral candidates, early-career practitioners, and educators, enhancing their communication, problem-solving, and commitment to strengths-based practices. It integrates partial credits for MSW courses and serves as a standalone certificate program, combining lectures, case studies, and hands-on assignments to ensure comprehensive understanding and skill development.
