

3. No candidate shall be considered for the purpose of counselling, who will be reporting after 11:30 AM.
4. A Merit list of candidates will be prepared on the basis of score of GAT (General Aptitude Test), among the candidates who will be present on the day of offline counselling dated 29th August, 2025.
5. The candidates listed in **Merit list** [prepared on the basis of score of GAT (General Aptitude Test)] are required to pay the fee (**₹ 7,100 for 1st Semester**) through the **Online Payment methods**.
6. Payment of the fee alone does not guarantee provisional admission. Candidates must meet the prescribed eligibility criteria (as per university admission notice) and submit the required documents. (As listed below).
7. All candidates listed above are hereby informed that failure to appear for this counselling session will result in the forfeiture of their chance to secure provisional admission for upcoming counselling sessions.
8. All the candidates must possess ABC Id at the time of admission without which the candidature will be cancelled.
