2. This is not a Spot/ Open Counselling. Only candidates listed above will be considered for counselling.

3. No candidate shall be considered for the purpose of counselling, who will be reporting after 11:00 AM.
4. A Merit list of candidates will be prepared on the basis of score of GAT (General Aptitude Test), among the candidates who will be present on the day of offline counselling dated 8<sup>th</sup> September, 2025.
5. The candidates who will be selected through **Merit list** [prepared on the basis of score of GAT (General Aptitude Test)] will require to pay the fee (**₹ 7,100 for 1<sup>st</sup> Semester**) through the **Samarth Portal on the day of counselling in the Department only.**
6. Payment of the fee alone does not guarantee provisional admission. Candidates must meet the prescribed eligibility criteria (as per university admission notice) and submit the required documents. (As listed below).
7. All the candidates must possess ABC Id at the time of admission without which the candidature will be cancelled.
8. All the candidates selected through merit list are required to be submit following mentioned documents without fail:
  - a) 10<sup>th</sup> /HSC marksheet original and two photocopies
  - b) 12<sup>th</sup> /HSSC marksheet original and two photocopies
  - c) Caste/ PwD/ EWS/ Income certificate (whichever applicable) Original and two photocopies  
(Income certificate issued 1st April, 2025 onwards, if applicable)
  - d) Gap Certificate, if applicable and two photocopies
  - e) CUET UG Application form (2 Copies)
  - f) CUET UG scorecard (2 Copies)
  - g) GGV Registration/ Enrolment Form of B.A. LL.B. (2 Copies)
  - h) Four passport size photographs (white background preferable)
  - i) Migration, Character Certificate and Transfer Certificate, Original and two photocopies of each
  - j) A Copy of Aadhar Card (Non-mandatory)
9. Decision of Admission committee in all regards will be binding.
