Interested candidates are advised to report physically with all relevant **original documents** at the Chemistry Department, GGV, strictly between **09:00 am and 11:00 am**, without fail. The candidate must report within the time given above for consideration of his/her admission to the BSc Chemistry program. The candidates are also informed to bring all the following documents **in two sets**, failing which the candidature will not be considered for admission.

1. CUET Application and Admission Form (If applicable)
2. CUET UG Scorecard and Admit Card (If applicable)
3. 10th and 12th mark sheets and certificates.
4. Transfer Certificate (TC)/ Character Certificate (CC) /Migration Certificate (Original)
5. Recent passport-size color photograph (**4 copies**)
6. Latest (Issued after 01 April 2025) and valid caste/EWS certificate (if applicable)
7. PWD Certificate (if applicable)
8. Latest (Issued after 01 April 2025) Income certificate (if applicable, required for OBC-NCL candidate)
9. Domicile Certificate
10. Gap certificate in the form of an affidavit in the original (if applicable)
11. Aadhar Card
12. The mobile/debit card has a sufficient balance for online payment of the semester fee of Rs 7050/-.

Important Notice: If a candidate does not report physically / is unable to present the required documents / is found ineligible for the program, their admission will be cancelled after verification, and the seat will be offered to the next candidate. Mere participation in offline counselling or being listed in the merit list does not guarantee confirmed admission. Final admission will only be granted upon verification of documents and fulfillment of the eligibility conditions. If any candidate is inadvertently admitted but later found ineligible, the Vishwavidyalaya will cancel their admission without prior notice.
