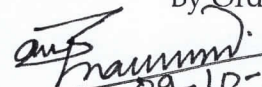
**For the Award of the Degree of Doctor of Philosophy (Ph.D.)**

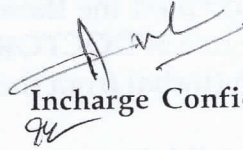
